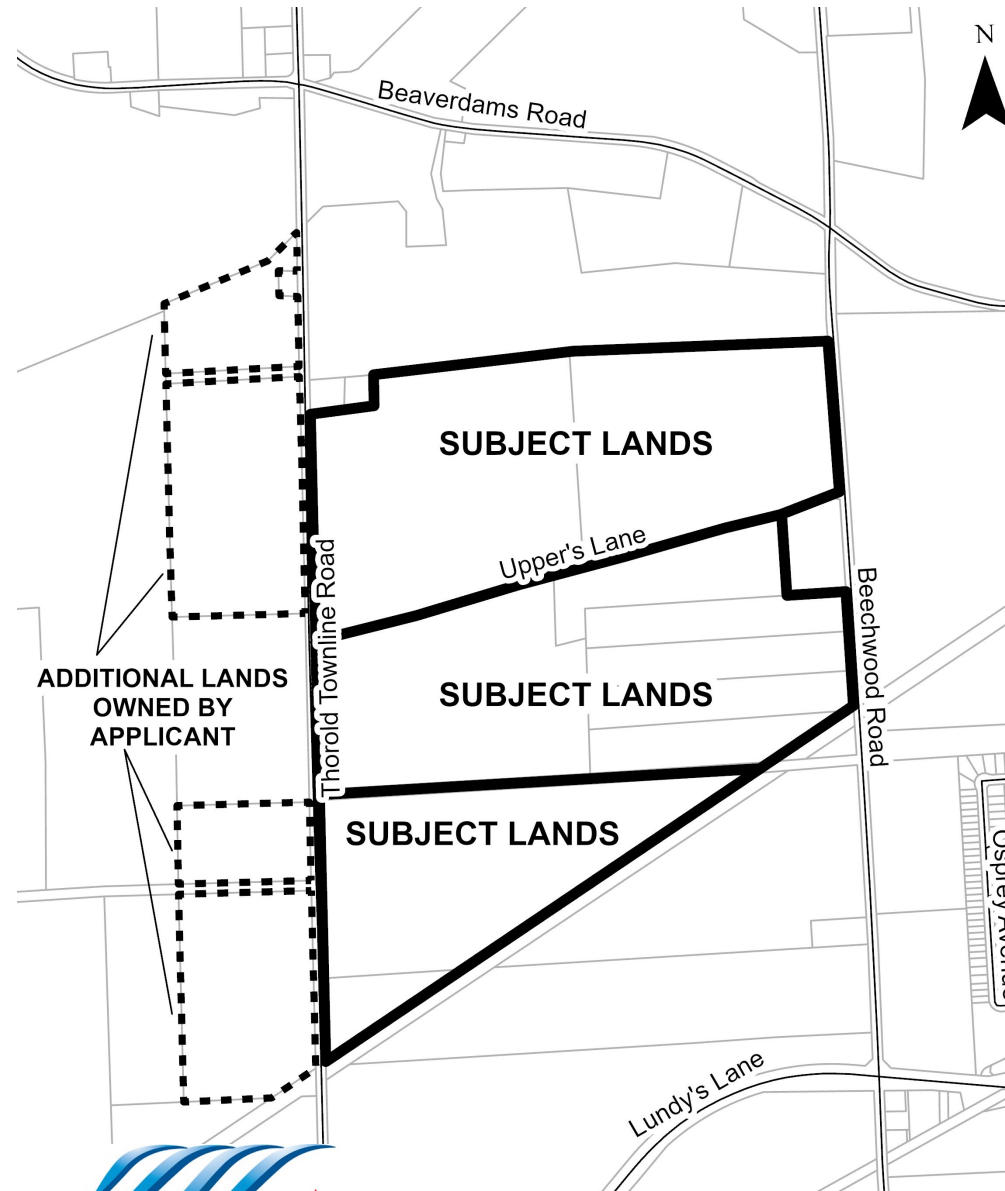

Process- Planning Act

PLANNING ACT: REGIONAL/LOCAL OFFICIAL PLAN AND ZONING AMENDMENT PROCESS (Region of Niagara and City of Niagara Falls)

Preconsultation with the Region and City	Applicant prepares all Required Technical Reports	Applications Submitted to the City & Region	City/Region circulates the application to agencies for review and peer review	Council statutory public meeting	Municipal staff review all information, and prepared a report and recommendation to approve or deny the application	Council makes a Decision	OLT appeal period (20 days after the decision)

Status of Process- Planning Act

1. Application circulated (January)
2. Review and Consultation (January-March)
3. Open House (March 23)
4. Comments received, reviewed and sent to applicant (end of April)
5. Revised submission (TBD)
6. Review of revised submission (TBD)
7. Two Statutory Public Meetings- City and Region (TBD- Notice provided at least 20 days prior)
8. Recommendation report to City and Regional Council (TBD)
9. Council decisions on applications (20 day appeal period)

Joint Agency Review Team

- Joint Agency Review Team (JART) formed
- Team of staff from the Region, City, Niagara Peninsula Conservation Authority (NPCA)
- Share information, resources and expertise
- Coordinated technical review and engagement/consultation
- Technical JART report to be used independently by staff at each agency
- **JART does not make recommendations**

Process- Aggregate Resources Act

AGGREGATE RESOURCES ACT:

LICENCE APPLICATION PROCESS (Ministry of Northern Development, Mines, Natural Resources and Forestry - NDMNRF)

Preconsultation with NDMNRF	Preparation of Technical Reports, Site Plans and Summary Statement	Application Submitted to NDMNRF	Application deemed Complete by NDMNRF, Notice if posted on the Environmental Registry (EBR)*	Applicant initiates the Notification and Consultation process (registered letter to landowners within 120 m, sign on property, notice in local newspapers)	Applicant works to address comments and resolve issues raised during the comment period	At the end of the 2 year process or before, Applicant documents the process and submits to NDMNRF	NDMNRF makes a decision on the application. Where there are unresolved objections, NDMNRF refers the application to LPAT
-----------------------------	--	---------------------------------	--	--	---	---	--

- The ARA has a 60 day “Notification and Consultation Process” during which a Public Information Session must be held. Anyone can submit comments or objections during the 60 day notice period.
- The Applicant has up to 2 years to address comments and try to resolve issues. At the end of the 2 years, if there are unresolved objections, the application is referred to the Ontario Land Tribunal (OLT)
- If all issues are resolved, the Minister can issue the License. Zoning must be in place before a license can be issued.
